The responding organization (Bidder) should provide the following:-

- 1. Name of the participating organization or participating organizations (if more than one) in the responding consortium, including their scope of involvement and Agreement.
- 2. Number of years of incorporation of the participating organization or participating organizations (if more than one).

## 2.1.3 Maintenance Services Period

The bidder shall give (1) One year comprehensive UPS Maintenance Services located in branches across Pakistan as mentioned in the required scope of work of this document.

#### 2.1.4 Terms and Condition.

- a) Preventive maintenance shall be performed by the contractor on site at BOK Branch location.
- b) 2-Routine mandatory services per annum and response to maintenance calls as and when required.
- c) A well trained engineer availability on fault call within same day in major cities and 24 hours in remote area branches.
  - d) Testing and necessary adjustment/primary repairs to be carried out on site.
  - e) Critical spare parts inventory to be kept by the vendor.
  - f) Repair of faulty UPS (inclusive of all faulty parts) shall be carried out by the vendor.
  - g) Vendor shall provide back-up UPS in case the UPS is removed for repair.
- h) Bidder will be responsible for replacement of the faulty equipment/accessories at its own cost certifying that the goods supplied confirm the required specifications and are secured and that in the event any material being found defective or not conforming to specifications bidder will be held

responsible for all losses and that the unacceptable items shall be substituted with the acceptable items at bidder expense and cost.

i) Payment shall be made bi-annually against Field Service Report.

# **TERMS & CONDITIONS**

- Bidder is required to submit Sealed proposals to the office of the Head Procurement Division, The Bank of Khyber on or before <u>Friday 5<sup>th</sup> October, 2018 at 3:30PM</u>, which shall be opened on the same date at <u>4:00PM</u> at The Bank of Khyber, Head Office.
- 2. Company should sign and stamp BoK bidding document and must attach with its proposal.

- 3. All the firms applied for the Tender must provide documents in line with the Mandatory requirements and should qualify the Technical Evaluation Criteria. If any firm fails to qualify the Technical Evaluation Criteria, then Financial Proposal of the same will not be opened.
- 4. Company seal / stamp must be fixed on both Technical Proposal and Financial Proposal.
- 5. Any bid submitted after due date and time will not be entertained.
- 6. Bid Security of two percent (2%) of the total bid amount must be attached with financial proposal in separate sealed envelope in favor of The Bank of Khyber. An affidavit to this effect to be placed with technical proposal.
- 7. Technical & Financial proposals to be clearly marked.
- 8. Suppliers / vendors quoting for more than one lot must quote separately in Sealed Envelope for each Lot mentioned in this document. Each lot will be separately evaluated.
- 9. All prices quoted must be inclusive of all Taxes applicable, such as GST, Income Tax, etc.
- 10. The prices quoted shall remain valid for 120 days, after the date of opening the tender.
- 11. Failure to provide the requisite maintenance services within stipulated amount of time period will invoke. In addition to that, two percent (2%) Bid Security amount will be forfeited.
- 12. The Bank of Khyber will not be responsible for any costs or expenses incurred by bidders in connection with the preparation or delivery of bids.
- 13. All currency in the proposal shall be quoted in Pakistan Rupees (PKR).
- 14. Bidder is hereby informed that the Bank shall deduct tax at the rate prescribed under the tax laws of Pakistan, from all payments rendered by any bidder who signs a contract with the Bank. Bidder will be responsible for all taxes on transactions and/or income, which may be levied by government.
- 15. This bidding document and any contract executed pursuant to this document shall be governed by and construed in accordance with the laws of Pakistan. The Government of Pakistan and all bidders responding to this bidding document and parties to any contract executed pursuant to this document shall submit to the exclusive jurisdiction to Courts.
