FORMULA: GROSS Total cost for the bid will be calculated as per below mentioned formula:-

- 1. For Quantity = cost per one item to be calculated.
- 2. For wiring/cables = Cost per one Meter (serial 19, 20 & 21).
- 3. Total cost will not include services charges/special offer as mentioned at serial 45 & 46.
- 4. Price per item will include all relevant taxes.



General Tender Terms & Condition Required for Bidding of CCTV System:

- 1. Tender will be strictly followed/processed as per KPPRA procurement rules 2014.
- Quotations should be submitted in a single package containing Technical and Financial proposal duly complete in all respect along with call deposit in favor of The Bank of Khyber for Rs.100,000/- of bid amount as earnest money.
- 3. Bid security to be closed in with the envelope containing financial bid only.
- 4. Vendor should be authorized Distributor/Dealer of the brand offered and should attach its Certificate with the tender.
- 5. Vendors are required to quote only those items which are strictly according to the specifications otherwise the whole bid may be rejected, no substandard brand/local items will be considered.
- 6. Certificate/Affidavit that the firm/company is not in litigation with any client.
- 7. List of vendors / list of previous project work/experience shall also be provided with the tender.
- 8. Vendor should provide import documents like HAWB & Bill of Entry as evidence that equipments are genuine and import directly from the manufacturer.
- 9. The Vendor shall meet 100% of the Technical/Financial specification in the Tender.
- 10. Vendor will provide complete solutions for the new DVR/CCTV installations as well as existing system already installed in the branches/Head office.
- 11. Vendor will be responsible for supply, cabling, installation, repairing, testing and training of the staff related to DVR/CCTV System.
- 12. Technical and Financial bids to be sent in two separate sealed envelopes further packed in one packet, clearly mentioning the Company name.
- Technical bid will be opened first as per given schedule, however date for the opening of the Financial bid will be communicated to the successful bidders after preparation of Technical bid results.
- 14. Those who fail to qualify the technical bid will not be called for the opening of the bid and their sealed financial bid will be returned to the authorized person accordingly.
- 15. Financial bid of the qualified/success bidders will be opened in presence of all concern/bidders as per date and time to be fixed later, which will be duly communicated to all accordingly as per KPPRA rules.
- 16. There may be selection of one or more than one vendors at National/Provincial level as per KPPRA rules/feasibility/ ensuring quality service.
- 17. Technical bid has got 40 marks where as financial bid has got 60 marks. The allocation of marks in the technical bid will be as per technical points illustrated in the technical bid, where as in the Financial bid the marks allocation will be as under:
 - a. The 1st lowest bid = 60 marks
 - b. The 2^{nd} lowest bid = 50 marks
 - c. The 3^{rd} lowest bid = 40 marks
 - d. The 4^{th} lowest bid = 30 marks
 - e. The 5th lowest bid = 20 marks
- 18. The overall position will be calculated as per securing of aggregate marks secured both in technical and financial bids accordingly.
- 19. The Price of the quoted item will be valid for the entire agreement period and the company will not demand for any increase in the given prices.

- 20. Warranty of the equipments shall not be less than 12 months and it will start from the date of installation.
- 21. The equipment free delivery and installation at various stations throughout Pakistan will be the responsibility of the Vendor.
- 22. All quoted rates should be inclusive of GST and all applicable Governments Taxes.
- 23. Vendor will also be required to carry out Maintenance/repair services of the existing DVR/CCTV System, already installed at different branches/Head office, at all provinces including AJK/FATA and GIGIT BALTISTAN.
- 24. Any vendor not fulfilling above mandatory requirements may not be considered/deem disqualify for provision of its services for Bank of Khyber.
- 25. Successful bidder will be informed after approval of bid by the competent authority.
- 26. Quoted amount will be valid up to April 30, 2019.
- 27. Any query/clarification to be asked in written from Head Security Deptt before date of deposit of bids.
- 28. **Successful** bidder would enter to a security services contract of Two **(02)** years extendable on yearly basis upon satisfactory performance.
- 29. The maintenance of the branches will be done on complaint to complain basis for which the vendor will be authorized only travelling charges as per distance mutually agreed.
- 30. No Quarterly services charges will be paid.
- 31. Installation charges will be paid for the new openings branch installation of DVR/CCTV system.
- Installation charges will be paid for the shifting of old branch/ complete re- installation of DVR/CCTV system.
- 33. No installation charges will be paid for the replacement of faulty CCTV/DVR system already installed in the branch, rather travelling charges will be paid as per distance/duration.
- 34. Incase of failure of the existing DVR/ CCTV Camera, backup DVR/CCTV camera will be provided by the vendor till final repair/ replacement as per requirement.
- 35. Response time will not be more than 24 hours, failure of which a penalty of Rs-10,000/ will be imposed as fine per delayed complaint.
- 36. Bidding shall be conducted under **"Single Stage Two Envelopes"** (Technical and Financial bids) method laid down in KPPRA Rules 2014.
- 37. Bidders shall submit their bids with proper Indexing Table / Page Numbers and attach all the mandatory / required documents.
- 38. The company shall bear all costs associated with the preparation and submission of its documents, while the BOK, in no case shall be responsible or liable for those costs, regardless of the conduct or outcome of the tendering process.
- 39. A prospective company requiring any clarification(s) may notify to BOK or an Officer authorized on its behalf in writing for any clarification. The BOK or concerned Officer authorized on its behalf will respond to any request for clarification, which is received well before (approximate 05 working days or more) to the deadline set for the submission of bids. Copies of BOK response will be forwarded to prospective companies (if not already clarified in the tender document or deemed necessary for the company).
- 40. At any time prior to the deadline for submission of bids, the BOK may, for any reason, whether at its own initiative or in response to a clarification requested by a prospective company, modify the tender document by issuing addendum.

- 41. Any addendum thus issued shall form eternal part of the tender document. To afford company's a reasonable time frame in which to take an addendum into account in preparing their bids, the BOK may at its discretion extends the deadline for submission of bids.
- 42. Bid Documents and related correspondence will always be in the English Language.
- 43. The bid should have a covering letter on printed letter head of the firm. All pages of the bid shall be initiated / signed and shall bear official seal of the person(s) authorized to sign/endorse.
- 44. All the relevant technical literature in English Language should be attached with the bid.
- 45. Price /bid for each item offered, should be quoted in Pak Rupees.
- 46. The price / bid offer quoted should be firm, final and clearly written / typed without any ambiguity.
- 47. The bid price should include all the government taxes, as per prevailing taxation rates of provincial / federal governments etc (e.g., GST, Income Tax, Withholding Tax etc).
- 48. The bidder shall deem to have obtained all related information as to the requirements thereto which may affect the bid offer / price if required.
- 49. The bid security / earnest money may be forfeited / confiscated:
 - a. If a bidder withdraws his bid during the period of bid validity.
 - b. If the bidder does not accept the correction of his bid price.
 - c. In the case of a successful bidder, if he fails to furnish the required Performance security or sign the contract agreement.
 - d. If the bidder fails to provide the requisite security services.
 - e. If the bidder fails to fulfill the mandatory requirements upon which he has given certificates / affidavits etc.
- 50. To assist in the examination, evaluation and comparison of the bids the committee at its discretion may ask the bidder for a clarification of its bid.
- 51. The request for clarification and the response shall be in writing and no change in the price or substance of the bid shall be sought offered or permitted. <u>Arithmetical errors will be rectified</u> on the following basis:
 - a. If there is a discrepancy between unit price and total price that is obtained by the multiplying the unit price and quantity, the unit price shall prevail and total price shall be corrected. If there is a discrepancy between the words and figures the amount in words shall prevail.
 - b. If there is a mistake in addition / totaling that can be corrected.
- 52. Technical Bid should be submitted in sealed envelope containing necessary information regarding tender notice and warning message, "DO NOT OPEN BEFORE THE THRUSDAY THE 30th April 2017, AT 3:00 PM".
- 53. Opened, e-mailed or faxed bids will not be accepted.

- 54. Any bid received by the Bok after the date and time of tender opening will be returned as unopened to sender / bidder.
- 55. The Committee will publically open the Sealed "**Technical Bids**" first while the "**Financial bids**" of all prospective bidders would be kept in safe custody at BOK and opened later as per date fixed, duly communicated to all.
- 56. After declaration of Technical Bid Results, the <u>Sealed Financial Bids</u> of only Technically Qualified firms only would be opened publicly at tim<u>e / date to be announced later</u>.
- 57. Whereas, Sealed Financial Bids of technically non-qualified bidders will be returned as unopened /unprocessed to the bidder.
- 58. The bidding company's name, bid price, tender security and such other details as the committee at its discretion may consider appropriate, will be announced at the time of Sealed Financial Bid opening process.
- 59. The relevant committee will resolve any issue raised by the bidders, on the spot. Any issue related to the proceeding after the same have concluded, shall not be entertained verbally or in writing.
- 60. The bids received after last date and time of submission will not be accepted/considered.
- 61. Quotations complete in all respects should reach <u>Incharge Security Deptt</u>, <u>The Bank of Khyber</u>, <u>Stat Life Building</u>, <u>The Mall Peshawar</u> on or before <u>30.04.2017</u>, before <u>12.00 p.m</u>. and will be opened on same day at <u>03.30 p.m</u>.
