In the absence of eligibility criteria, any bid document will be considered non-responsive.

Validity of the offer: 90 days from the date of opening of the bid; bid security is 2% of the total bid amount for each lot; the last date of submission is January 15, 2024, at 11:30 AM. The date and time of opening bids are January 15, 2024, at 12:00 PM.

### General Terms & Conditions:

- The bidder shall submit a sealed envelope with 2% bid security of each lot, clearly marked lot number and description of lot.
- Bidder will apply for each lot separately along with bid security.
- Combine bid for all lots will not be entertained.
- Partial bid against any lot will not be entertained.
- Bid amount shall be inclusive of all types of taxes.
- Bid against each lot must be above the reserve price. Below the reserve price bid against any lot will be non-responsive.
- In case of a bid tie, the procuring entity shall invite a revised bid from only those bidders who have quoted same rates and contract shall be awarded to the bidder quoting the revised highest bid.
- A bid so revised as above shall only contain a revised quoted rate or price and the bidder shall not be permitted to change the terms and conditions, technical details, documentation or any other aspects of their original bid.
- In case the highest price bidder fails to sign the disposal contract, the Bank shall forfeit the bid security and may offer the next highest bidder for award of the contract and so on.
- The Bank may negotiate for the award of contract with successful bidder, including maximization of price, for the benefit of Bank.
- The highest price bidder shall be considered successful for each lot.
- Proper announcement will be made of successful bidder(s) and an intimation letter will be issued to each successful bidder separately.
- Successful bidder liable to pay bid amount within 15 days from the date of intimation of successful bidder, failing which 2% bid security (Call Deposit) shall be forfeited and offer will be given to next highest bidder.
- Items will be handed over on 100% payment.
- Successful bidder shall bear all types of expenses for shifting of items from the store.
- Un Successful bidders bid security (Call Deposit) shall be returned.
- Bank of Khyber employees (permanent/contractual or any employee of an outsourcing company dealing with Bank of Khyber) are not allowed to participate in the bid.
- The bank reserves the right to cancel bid of any lot(s) or cancel the disposal process.
