- 6. Successful bidder shall provide Rs.500,000/- performance guarantee (issue by the schedule Bank only) in favor of the Bank of Khyber, before execution of contract. Other Bid Securities will be returned.
- 7. All prices quoted must be in PKR inclusive of all Taxes applicable, such as GST, Income Tax, etc.
