- 3. All the firms applied for the Tender must provide documents in line with the Mandatory requirements and should qualify the mandatory requirements. If any firm fails to qualify the mandatory requirements, bid shall be considered as nonresponsive bid.
- 4. Bids not complying with all the given clauses in this tender document are liable to be rejected.
- 5. Bid Security 2% of the total bid amount (any banking instrument excluding Pay Order) must be attached with the proposal in separate sealed envelope in favor of The Bank of Khyber, as bid security.
- 6. Successful shall provide 10% of total bid amount Performance Guarantee (issue by the schedule Bank) in favour of the Bank of Khyber, before the execution of agreement and purchase order. Other bid security will be returned.
- 7. All prices quoted must be in PKR inclusive of all applicable Taxes,
- 8. The prices quoted shall remain valid for 90 days, after the date of opening the tender.

- 9. Delivery of all items must be made within 20 days of issuance of purchase order.
