7	The bidder must be registered entity and must be having well placed organizational structure. It must be having Offices in major cities and should have appropriate technical manpower.	Certificate of incorporation/registration to be submitted along with list of Offices across Pakistan and list of technical staff.		
8	Bidder shall provide warranty of the batteries	Confirmation of providing minimum warranty period of one year to be submitted.		

### GENERAL REQUIREMENTS/TERMS AND CONDITIONS

- Bid must be typed written, acceptance or rejection of hand written bid shall be sole discretion of the bank. There should not be errors and / or over-writings. Corrections if any should be made clearly and initiated with dates.
- All rates to be quoted in Pak Rupees and inclusive of all applicable Government taxes.
- Bids must be enclosed in a properly sealed envelope.
- Quoted batteries should be well populated.
- Supply / installation time should not exceed three working days from the date of placing of purchase order.
- The supplier shall be responsible for the delivery/installation/commissioning of the UPS at the specified location/branch.
- The Bank of Khyber reserves the right to choose the specification/ models/ makes at its discretion. The bidder must submit all the relevant documents/broacher/information material regarding the quoted brand.
- Quoted amount will remain valid up to one year from the date of framework contract.
- Framework contract shall cover all offices/branches of the bank throughout Pakistan.
- Bids received late shall not be entertained.
- The Bank of Khyber will not be responsible for any costs or expenses incurred by bidders in connection with the preparation or delivery of bids.
- Delivery of items must be made within a five working days of issuance of purchase order.
- All prices quoted must be inclusive of all Taxes applicable, such as GST, Income Tax, etc.
- Rate should be quoted in words and figures.
- No negotiations and revised bids will be allowed.
- In case of any conflict in bidders standard terms and terms & conditions of frame work contract with BOK, latter would prevail.
