- Bidder must be active taxpayer (FBR), evidence to be attached. In absence of active taxpayer evidence bid will be rejected.
- Bidder shall attach their valid CNIC. In case of expired CNIC, NADRA renewal slip must be attached.
- Corona Vaccination Certification of bidder must be attached with bid, in absence of corona vaccination certificate, bid will be rejected.
- Bid Security (Call Deposit) must be issued from the personal bank account of the bidder.
- Bid Security (Call Deposit) shall be issued by any schedule bank of Pakistan. Only Call Deposit Receipt shall be considered eligible bid Security issued by the schedule bank.
- Bid Security (Call Deposit) favouring The Bank of Khyber.
- Bid amount shall be considered without all applicable taxes on sale of vehicle.
- Highest price bidder above the reserved price shall be considered successful for each vehicle among all participating bidders.
- Successful bidder liable to pay all tax of Government Federal/Provincial on sale of vehicle prevailing at time of payment, above the bid price.
- 5% bid security (Call Deposit) of total bid amount shall be required for each vehicle separately. Combined bid security for more than one vehicle shall not be entertained, and bid will be rejected.
- Bidder shall submit confidential sealed envelope for each vehicle with 5% Bid Security (Call Deposit) of total Bid amount, vehicle Make, model and registration shall be mentioned on the right corner of the sealed envelope.
- Successful bidder of Government Number Vehicle shall require obtaining fresh Number from Excise and Taxation Department, and liable to surrender Government Number. Expenses of number for vehicle shall be borne by the successful bidder.
- Successful bidder liable to pay bid amount and applicable taxes within 7 working days from date of intimation of successful bidder, failing which 5% bid security (Call Deposit) shall be forfeited and offer will be given to next highest bidder.
- Successful bidder shall bear all type of expense on picking of vehicle from respective places after paying all dues.
- Successful bidder shall be bound to transfer vehicle to his/her name within one month period after taking over possession of the vehicle from the Bank.
- Successful bidders bid security (Call Deposit) shall be returned on production of evidence of transfer of ownership of vehicle to his/her name.
- Unsuccessful bidders bid security (Call Deposit) shall be returned.
- The Bank of Khyber reserves the right to accept or reject all bids or any bid without assigning any reason.
- The Bank of Khyber employees (permanent/contractual or any employee of outsource company dealing with the Bank of Khyber) are not allowed to participate in the bid.
