- Bid Security (Call Deposit) shall be issued by any scheduled bank of Pakistan. Only Call Deposit Receipt shall be considered eligible bid Security issued by the scheduled bank.
- Bid Security (Call Deposit) favouring Bank of Khyber.
- Bid amount shall be considered without all applicable taxes on sale of vehicle.
- Highest price bidder above the reserved price shall be considered successful for each vehicle among all participating bidders.
- Successful bidder liable to pay all taxes of Government Federal/Provincial on sale of vehicle prevailing at time of payment, above the bid price.
