The procurement shall be carried out through Negotiated Tendering under applicable provisions of the Khyber Pakhtunkhwa Public Procurement Rules, 2014, as amended, due to the urgent nature of the requirement.

Scope of Works:

The works shall include civil/renovation works, partitioning, flooring, false ceiling, electrical works and other allied works in accordance with the approved BOQs, drawings, technical specifications and scope of work.

Mandatory/Eligibility Requirements:

Interested firms must fulfill the following minimum requirements:

- PEC Registered Engineering Firm – Category C-3 (Mandatory).
- Valid NTN, GST and KPRA registrations.
- Relevant experience in similar civil/renovation works, preferably for banks, government offices or institutional premises.
- Valid undertaking regarding non-blacklisting/debarment.
- 2% Bid Security in the form of CDR in favour of Bank of Khyber.
- Undertaking to provide 10% Performance Security upon award of contract.

Completion & Penalty:

The contractor shall complete the works within the stipulated period specified in the Contract/Work Order. Liquidated damages/penalty for delay attributable to the contractor shall be imposed as per the Contract/Work Order and may be recovered from pending payments or Performance Security.

Procurement & Submission Procedure:

The procurement shall be conducted through Single Stage–Single Envelope Procedure.

Bidders shall submit their complete Technical and Financial Proposals, duly signed and stamped, in a sealed envelope clearly marked with the name of the procurement and location(s).
