1. About The Bank of Khyber

The Bank of Khyber (BOK) is a Listed Scheduled Commercial Bank with majority of shares held by KP Government and having 170 branches; including 84 Islamic Branches. The Bank of Khyber established in 1991 through Act No. XIV, passed by the Provincial Legislative Assembly of the KHYBER PAKHTUNKHWA Province of Pakistan. It was awarded status of a scheduled bank in September 1994. The Bank of Khyber enjoys a unique position, stands out amidst the other banks operating within Pakistan, and has the privilege of being bracketed amongst the only three government banks in the country.

2. Scope of Work

The aim of the project is to co-locate the IT equipment at Tier-3 Certified Data Center facility in Karachi where mission critical applications of the bank should be hosted. Architecture of infrastructure should be designed in such a manner that all components are redundant and in high availability mode. Availability of services must be ensured for maximum uptime and optimized as well.

The proposed Data Center should have at least, but not limited to, the following facilities: -

- Proposed site should be at least Tier III infrastructure Certified / from International body and must have minimum 99.982% up time SLA.
- Must provide the connectivity through Meet-me room to BOK's server.
- Meet-me room in the Data Center should have multiple Service Provider terminations that BOK may select as per requirement or need.
- Advance Firefighting (NOVEC) and automatic alarm system should be installed in the facility.
- All equipment including cabinets, power cord, and network cables etc., should be properly labeled and must comply with Data center standards.
- No additional costs/ one time or re-occurring will be charged from the BOK service providers.
- Dual feeds to each cabinet must come from different UPS groups and PDUs.
- The facility must be properly covered by advanced surveillance system having night vision features for clearly recognizing the visitors.
- Provisioning of physical Security Guard with 24x7x365 surveillance.
- Facility should have Backup power generators with sufficient load and running capacity/



Ups System should be N+1.

- Precision air condition system (N+1 redundancy) with humidification /Dehumidification, guaranteeing the temperature between 18°C to 23°C & humidity<=65%. As per Data Center standards and equipment vendors' specifications.
- Air Purifier should be available to clean the air inside the datacenter.
- STS provision should be available for single power supply equipment to maintain redundancy.
- DR site should be easily accessible for BOK staff to maintain and look after Operations.
- The data center facility should be equipped with an advanced maintained environment monitoring system like BMS or DCIM to monitor the facility.
- Access control or biometric authentication system should be properly installed having logging facility.
- Space required for 02. No's of staff of M/S BOK on permanent basis in the proposed site's working area.
- Service provider must have provision for shared or dedicated room for BOK.
- Easy physical & remote access provision for Bank of Khyber nominated resource personnel for routine operations on its environment.
- The bidder should provide MPLS link between the proposed DR Site and primary site located at IT Head Office 4th Floor State Life Building, 34 the Mall Peshawar Cantt.
- The bidder should provide 20 Mbps MPLS link between BoK Karachi site situated at 7th Floor BRR Tower, I.I. Chundrigar Road, Karachi and proposed DR site.
- Aggregation link of 100 Mbps at proposed DR site for termination of BOK branches.
- Share log or events details if required to BOK for regulatory justification incident management (Log / events reports required within same day / COB).

TERMS AND CONDITIONS

- 1. The Procurement shall be conducted in accordance with the Khyber Pakhtunkhwa Procurement Rules 2014 on **Single Stage Two Envelope Procedure**.
- 2. Bidders should submit two separate sealed envelopes, one for Technical Proposal and One for Financial proposal.
- 3. Bidders are required to submit both sealed proposals to the office of the **Head Procurement Division, The Bank of Khyber** on or before 23-01-2019 **at 03.30 PM**. Tender shall be Opened on same day at 04.00 PM at The Bank of Khyber, Head Office.
- 4. Company seal / stamp must be fixed on both Technical Proposal and Financial Proposal.
- 5. All the firms applied for the Tender must provide documents in line with the Mandatory requirements and should qualify the Technical Evaluation Criteria. If any firm fails to qualify the Technical Evaluation Criteria, then Financial Proposal of the same will not be opened.
- 6. Any bid submitted after due date and time will not be entertained.
- 7. Call Deposit of two percent (2%) of the total bid amount must be attached with financial proposal in separate sealed envelope in favor of Head Procurement Division, The Bank of Khyber. Technical proposal envelop should also contain an confirmation to this effect.
- 8. All prices quoted must be inclusive of all Taxes applicable, such as GST, Income Tax, etc.
- 9. The prices quoted shall remain valid for 120 days, after the date of opening the tender.
- 10. In case of failure to complete the project under specified time. The work order shall stand cancelled and call deposit would be forfeited.
- 11. The Bank of Khyber will not be responsible for any costs or expenses incurred by bidders in connection with the preparation or delivery of bids.
- 12. No negotiations and revised bids will be allowed.
