ANNOUNCEMENT

Tender No. BOK/Proc/GSD/38/Nov/2021 floated on 4 November 2021 for Procurement for selection of 360-degree renovation and remodeling contractor for alteration, additional work, interior furnishing, landscaping, prefab auditorium in under construction 6 stories building of The Bank of Khyber at 24 The Mall Peshawar Cantt, under framework contract for one year under KPPRA Rules and procurement procedure for works and non consulting services single stage two envelope. Bid opening was held on 9 November 2021. Following bidders participated:

Following bidders did not qualify knockout round due to non-submission of following mandatory documents, reasons as follows.

Point 1 Company profile and provided documents did not match scope of work criteria mentioned for eligibility for participation of this this tender.

Point No.3, Proposal did not contain copy of registration with KPRA, but they registered with KPRA.

Point No.8 Proposal did not contain undertaking for provision of 10% performance security of total bid amount.

Point No.10, Integrity pact was not attached with your proposal.

Point No.12, Company profile did not contain any picture of exterior and interior of the projects which they have completed.

Point No.13, Proposal did not contain project execution plan for this tender.

Architect firm M/s. Imtiaz Ali Associates had thoroughly scrutinized proposal for tender No.BOK/Proc/GSD/38/2021 opened on 19 November 2021 and they did not find any evidence/documents in proposal which reveal that firm had done any similar work according to our mandatory requirement following clause and Schematic Design .

1	Bidder must have 360-degree standalone renovation, remodeling, Civil work, electrical installation interior design furnishing, landscaping, manufacturing of furniture products having experience of at least 10 years in multi stories building having at least 6 stories eligible to participate in this tender. Evidence to be attached. Evidence which includes subletting of works shall be not considered.

Keeping in view of Architect consultant M/s. Imtiaz Ali Associates scrutiny of company proposal, company did not meet eligibility criteria mentioned in the clause 1 of mandatory and knockout round; therefore, proposal is nonresponsive.



M/s. Ahmad Associates (renamed Ibna Al Aziz) met all mandatory requirements mentioned at knockout round, Architect Consultant M/s. Imtiaz Ali Associates has given clearance of the company. Bidder has obtained 96 marks out of 100 marks.
